

OFFICIAL MINUTES FROM THE BOARD OF TRUSTEES MEETING OF THE
ARKANSAS SCHOOL FOR THE BLIND AND VISUALLY IMPAIRED
ARKANSAS SCHOOL FOR THE DEAF

The Board of Trustees for the Arkansas School for the Blind and Visually Impaired and the Arkansas School for the Deaf met for their monthly meeting May 20, 2025, at the Arkansas School for the Deaf Leopard Spot (formerly the Tornado Shelter).

Present: Robert Fagan, Chair; Dr. John McAllister, Vice Chair; Cary Smith, Board Member; Philip Powell, Board Member; Jerry Belew, Board Member, and Holley Mott, ASD Parent Representative, K. Nicole Walsh, ASD Superintendent; Dr. Chris Barnes, ASBVI Interim Superintendent; Interpreters; Members of the community.

Mr. Fagan called the meeting to order at 5:00 pm. He said there was a lot of recognition for the meeting tonight. He asked Dr. Barnes to introduce the senior class. Dr. Barnes said this is the 2025 Senior Class for ASBVI. The students introduced themselves and told them their plans for after graduation. Ms. Walsh asked the board if a discussion item could be added after her superintendent report. She said there was new information since the agenda had been approved. It is their curriculum for next year.

Ms. Walsh thanked Nabholz for the fabulous meal they provided the board with today. She asked Paul and Chris to give an update on the construction. Chris said all the buildings have been demolished. They are cleaning up footings and the demos should be wrapped up this week. He said they would start site utilities in about a week or so. Paul said they are pricing design development drawings. He said if you imagine zero to 100% drawings, they are probably at the 60-65% mark. They have a very good understanding of what is in the building. They are taking that and getting pricing from subcontractors to make sure they are tracking it along. The project is going great. The design team has been incredible and the team at the school. Taking the design development drawings, they will move into what they call construction drawings (which they will actually build off of). They have gotten structural drawings for the north half of the building. They are looking to procure some of those items to keep moving forward.

Mr. Powell asked if they were still on track. He said absolutely. Ms. Walsh said she understood they are nearly a month ahead.

Dona VanDevender talked about the curriculum selection that has been made for literacy for next year.. She they are excited about the new curriculum – American Reading Company (ARC). It is divided into two parts. One part is called IRLA, the other is Core Curriculum. IRLA is widely used, more than 25 deaf schools are using it. She said some blind schools use it, but she did not know of any blind schools using the Core Curriculum. She said IRLA improved student stamina and interest in reading. It is based on phonetic units. She said they are looking forward to purchasing and implementing for the 25/26 school year.

Ms. Walsh said this is what ASD is using, and she is encouraging ASB to look into it also. She said there are a lot of benefits to sharing a curriculum, it allows teachers to have a partner who is working on the same thing. It allows students to have similar experiences. She said they want to be very sure it meets the students' needs.
